### **Background of the project:**

State High Level Clearance Committee in its 51st meeting held on 2.3.2018, has approved the project proposal M/s Greenko Solar Energy Pvt Ltd., to establish a unit for “Integrated Renewable Energy project consisting of 600 MW Pumped Storage Energy Project 1000 MW Solar Power Project and 400 MW Wind Power Project” with an investment of Rs.11,790 crore in 6000 acres of land to be purchased U/s 109 of KLR act in various Sy. Nos. in Tallur, Karalakatti, Basidonidoddi and other Villages of Saudatti, Ramadurga, Khanapura, Bailahongal, Gokak, Kittur and Belgavi Taluks in Belgavi District and accordingly, Government Order No.CI 83 SPI 2018, dated: 12.3.2018 was issued.

In the 52nd SHLCC meeting held on 03.12.2018 committee approved Capacity enhancement from 600 MW Pumped Storage Energy Project to 1260 MW Pumped Storage Energy Project with an additional investment of Rs. 2,805 crores at Tallur in Belgavi District and Government Order No. CI 83 SPI 2018, dated: 27.02.2019 was issued.

In the 53rd SHLCC meeting held on 23.03.2020 committee approved extension of time to implement the project for further period of three years accordingly Government Order No. CI 83 SPI 2018, dated: 16.06.2020 was issued.

  - 3496 acres 22 gunta of Navalgund Sirsangi Trust land in Munavalli Hobli of Saundatti Taluk, Belagavi dist. on lease basis for implementation of Solar & Wind Power Project. (Land Details attached as Annexure- B)
  - **Land required for the Pumped Storage project is:**
    - 257 acres of private land, out of which company purchased 76 acres of Private land from farmers for Pumped Storage Project in Karlakatti and Chakrageri village of Saundatti Taluk, Belagavi District. (List of Private land is attached as Annexure-C)
    - 150 acres 1.5 gunta land belonging to PWD/ KNNL (Irrigation Department) land which was acquired by the Government of Karnataka under the Malaprabha Project in Karlakatti and Chakrageri village of Saundatti Taluk, Belagavi dist. for the implementation of Pumped Storage Project. (List of PWD/KNNL land is attached as Annexure- D.)



4. Reimbursement of land conversion fee and capital investment subsidy as per applicable policy.
5. Grants and concessions from various depts.

**Observations:**

1. Company furnished certified copy of resolution of board of directors regarding formation of 100% subsidiary companies implementation of 1000 MW solar and 400MW wind project and also present shareholding pattern is certified by CA.
2. **Land: Company has identified a total of 9767 acres of land Out of which Land required for the solar & wind project is:**
  - 5862 acres 21 Guntas land in Tallur village, Yaragatti Taluk, Belagavi dist. Out of 5862 acres 21 Guntas company signed MOU for 3376 acres with the farmers. Documents pertaining to MOUs signed not furnished.
  - 3496 acres 22 gunta of Navalgund Sirsangi Trust land in Munavalli Hobli of Saundatti Taluk, Belagavi dist. on lease basis for implementation of Solar & Wind Power. Consent/agreement for which not obtained.

**Land required for the Pumped Storage project is:**

1. 257 acres of private land, out of which company purchased 76 acres of Private land from farmers for Pumped Storage Project in Karlakatti and Chakrageri village of Saundatti Taluk, Belagavi District.-Purchase documents not furnished.
2. 150 acres 1.5 gunta land belonging to PWD/ KNNL (Irrigation Department) land which was acquired by the Government of Karnataka under the Malaprabha Project in Karlakatti and Chakrageri village of Saundatti Taluk, Belagavi dist. for the implementation of Pumped Storage Project. Opinion from concerned departments to be obtained.
3. The company has sought grants and concessions from various departments which may be brought to the notice of the committee for discussion and decision.

**Recommendation of 100<sup>th</sup> LAC meeting:**

The representative of the company appeared before the Committee and requested approval for extension of time, purchase of additional land, reimbursement of land conversion fee and capital investment subsidy and other incentives and concessions from various Departments etc.

The Committee noted that the company is requesting for 3496 acres 22 gunta of land from Navalgund Sirsangi Trust, 150 acres 1.5 guntas of land belonging to PWD/KNNL (WRD).



The Committee decided to obtain opinions from D.C, Belgaum, Revenue Department, PWD and KNNL (WRD) and **deferred** the subject.

Company in its letter dated 30.1.2023 has requested for following approvals since obtaining opinions from concerned Departments takes time.

1. To grant time extension for **further 3 years to complete** all project activities of "Implementation of Integrated Renewable Energy Project (IREP) consisting of 1260 MW Pumped Storage Project, 1000 MW Solar Power Project and 400 MW Wind Power Project in various villages of Belagavi Distict by M/s Greenko KA 01 IREP Pvt Ltd.
2. To grant approval for inclusion of SPV Companies which are 100% subsidiaries of **M/s. Greenko KA01 IREP Pvt. Ltd.** for implementation of Solar and Wind Power projects and amendment as G.O as:
  1. **M/s. Greenko KA01 IREP Solar1 Pvt. Ltd.** to implement 1000 MW solar power component of the IREP project
  2. **M/s Greenko KA01 IREP Wind Pvt Ltd.** to implement 400 MW solar power component of the IREP project.
  3. **M/s Greenko KA01 IREP Pvt Ltd.** to implement 1260 MW Pumped Storage of the IREP project.

#### **Recommendation of 102<sup>nd</sup> LAC meeting:**

The representative of the company appeared before the Committee through V.C and requested for extension of time to complete all the projects and approval for inclusion of SPV companies.

The Committee noted that the opinions from D.C, Belgaum, Revenue Department, PWD and KNNL (WRD) are awaited. Committee will decide on the land only after getting opinions from the concerned authorities.

After detailed discussions, resolved to recommend to SHLCC for approval of following requests of the company:

1. To grant time extension for **further 3 years to complete** all project activities of "Implementation of Integrated Renewable Energy Project (IREP) consisting of 1260 MW Pumped Storage Project, 1000 MW Solar Power Project and 400 MW Wind Power Project in various villages of Belagavi Distict by M/s Greenko KA 01 IREP Pvt Ltd.
2. To grant approval for inclusion of SPV Companies which are 100% subsidiaries of **M/s. Greenko KA01 IREP Pvt. Ltd.** for implementation of Solar and Wind Power projects and amendment as G.O as:
  1. **M/s. Greenko KA01 IREP Solar1 Pvt. Ltd.** (subsidiary company) to implement 1000 MW solar power component of the IREP project.



2. **M/s Greenko KA01 IREP Wind Pvt Ltd.** (subsidiary company) to implement 400 MW solar power component of the IREP project.
3. **M/s Greenko KA01 IREP Pvt Ltd.** (holding company) to implement 1260 MW Pumped Storage of the IREP project.

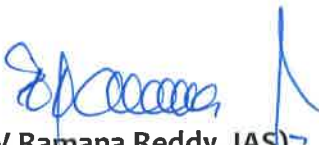
